So, they are interested but need more time. In the meantime, they are looking to permit putting a small cell phone tower in the right-of-way. The board has concerns about where it will be in the right-of-way. They asked Tamora if she could return in October so the board can do some research in the meantime with regards to putting this in the right-of-way. Tamora was fine with this.


